The Whole City is Involved!

The 32nd Annual Southern Watercolor Society Exhibition will be held in Columbus, GA in June 2009. Columbus State University and the University's "Friends of Art" will co-host the event. CSU has just renovated cotton/textile mills dating from the 1800's, along the Chattahoochee River, into a state-of-the-arts Fine Arts Complex. This is where the exhibition will be displayed, as well as the location for the Charles Reid Workshop. It is located in the historic district of the City and within walking distance of the newly refurbished Marriott Hotel (which was at one time a foundry for the Confederacy). This is where Charles and Judy Reid will be staying, and it is our recommendation for all workshop participants and SW members.

Workshop dates are: June 1–5, 2009. Charles will be conducting a great tri-subject workshop. 1-Day Landscape Painting, 2-Days Painting from Vintage Photography (yours, his or ours), and 2-Days Figure Painting with live models. There is a registration form on page 7 of this newsletter, or you can print it from the SW web site. On Thursday, June 4, 2009 all workshop participants will



be treated to a reception at the W.C. Bradley Museum (circa, 1885). This museum houses original works by some of America's foremost contemporary artists.

We have sent out emails to all our State Representatives asking for help in spreading the word about SW and the upcoming 32nd Exhibition. We are

hoping for 100% participation this year. Last year we had only three states that didn't have an entry and they were, Delaware, Oklahoma, and Washington DC. We have already heard from our State Rep. in Delaware, Jeanne Mueller who said she will have a painting ready for 2009!!! Thanks, Jeanne! Spread the word, please!

Good news is that Columbus Regional Hospital Foundation has chosen to sponsor the top tier of prize awards this year. They have given us: **Best of Show—\$3,500, Gold Award—\$3,000, Silver Award—\$2,000 and Bronze Award—\$1,500.** They are also going to print certificates for each artist whose work is accepted and design a plaque for each of the Top Award winners. We are working on the second tier of awards as we speak. So far we have Columbus Bank and Trust - \$1,000, The Aranas

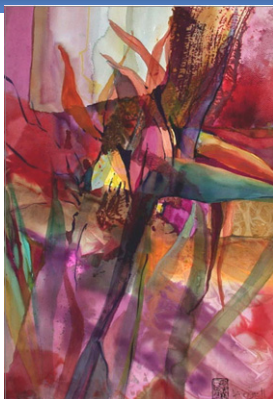

Susan M. Stuller, Midlothian VA. Her painting "A Balancing

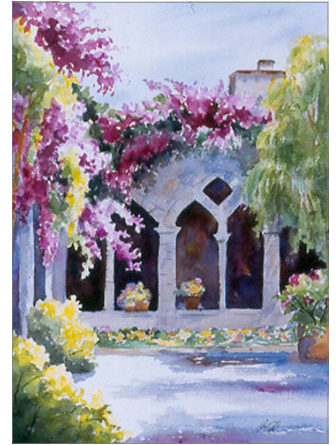

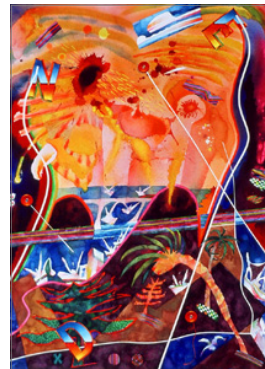
